#### Description of necessary first aid measures

## Section 5. Fire-fighting measures

### Extinguishing media

- Suitable extinguishing media** : Water spray, dry powder, foam

## Section 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

- For non-emergency personnel** : No action shall be taken involving any personal risk or without suitable training. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Put on appropriate personal protective equipment.
- For emergency responders** : If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also information in "For non-emergency personnel."
- Environmental precautions** : Contain contaminated water/firefighting water. Do not discharge into drains, surface waters, or ground water. ### Methods and materials for containment and clean up

- Small spill** : Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination. Dispose of absorbed material in accordance with regulations.

## Section 6. Accidental release measures

- Large spill** : Stop leak if without risk. Approach release from upwind. Dike spilled material where possible. Contain and collect spillage with non-combustible, absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor.

## Section 7. Handling and storage

### Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8).
- Advice on general occupational hygiene** : Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. See also Section 8 for additional information on hygiene measures.
- Conditions for safe storage including any incompatibilities**: Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10) and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.
